## **Payment Options**

The following payment options are available to you in settling your account.

### Option 1:

Payment in full by cash, check, or credit card upon completion of the arrangement conference.

### Option 2:

We will honor an insurance assignment which can be processed upon completion of the arrangement conference. We will need the insurance policy, a certified copy of the death certificate, and an assignment that will be accepted by the insurance company. Any charges not covered by the policy will need to be addressed at the arrangement conference. The policy can be used as payment for the funeral expenses. Insurance assignment is acceptable if the following criteria are met:

- The policy death benefit proceeds are verified by us, and all documentation is signed preceding the publication of the funeral arrangements.
- The policy is assignable and payable directly to the funeral home.
- The policy must be non-contestable (if in the contestable period the policy will not be accepted as a form of payment).

If the insurance company does not pay the balance of the statement, the person signing the Statement of Goods and Services is responsible for paying the full amount.

### Option 3:

We will honor pre-arranged funeral insurance which has been irrevocably assigned to Maberry Funeral Home, Inc.

**The person signing the Statement of Goods and Services at the time of arrangements will be responsible for all costs related to any collection of the account including attorney's fees in the amount of thirty-three and one-third percent (33.3%) of the outstanding balance at the time a collection attorney contacts you, which you hereby agree is reasonable. You further agree to pay an unanticipated late payment fee at the rate of one and one-half percent (1 ½%) per month on any amount due Maberry Funeral Home, Inc., which remain unpaid thirty (30) days after its due date.**

## PROFESSIONAL SERVICES OF FUNERAL DIRECTOR AND STAFF

**A. BASIC SERVICES OF FUNERAL DIRECTOR AND STAFF** \$1,700.00

Basic services of the funeral director, staff, and administrative services including consultation with the family and/or clergy regarding desired arrangements; obtaining information for filing necessary documents, certificates, forms and consents, including Social Security and Veteran's Administration when applicable; licensed personnel on call 24 hours a day, seven days a week; and/or custody of remains; routine administrative and office services and record keeping. Attention to all standard details regarding the funeral arrangements, including coordination with cemeteries, coordinating and arranging vehicles for funeral processions, and post funeral professional and administrative services; maintaining offices and equipment, display areas, warehouse, storage and non-public areas, garages, rest rooms, parking areas, general maintenance and custodial services, insurance, overhead cost and general supplies.

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.)

**B. EMBALMING (ALL CASES)** \$750.00

Embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

**C. OTHER PREPARATION OF THE BODY** \$250.00

General care of remains includes cosmetology, dressing and placement of the deceased in the casket for embalmed remains.

**D. DERMA-SURGERY** \$85.00

Restorative Procedures following the effects of trauma, Autopsy, or organ/tissue donation (Per Hour)

Recommended Preparation of remains for Direct Burial of Un-embalmed remains.

**FORWARDING REMAINS TO ANOTHER FUNERAL HOME** \$2,775.00

This charge includes transfer of remains to funeral home, Basic services of Funeral Director and Staff, embalming. The charge doesn't include merchandise, shipping container, and use of facilities for viewing or services or other preparation of body, transportation to airport or by transport service.

**RECEIVING REMAINS FROM ANOTHER FUNERAL HOME** \$2,025.00

This charge includes Basic services of Funeral Director and Staff, use of hearse for local transfer of remains to place of disposition (50 mile radius). (This charge does not include other preparations of the body per family request, removal from airport, (Piedmont Triad, Greensboro, NC \$345.00 and Charlotte Douglas \$453.00), merchandise, viewing/visitation, or funeral ceremony.)

**IMMEDIATE BURIAL** \$2,350.00 to \$8,545.00

Our charge for immediate burial without visitation or ceremony includes transfer of remains to the funeral home, hearse to cemetery and basic services of funeral director and staff. (Opening and Closing Grave not included.)

Our charge for direct cremation without ceremony includes basic services of funeral Director and Staff, transfer of remains to the funeral home, hearse to crematory, medical examiner certificate (\$100), and crematory fee (\$400), and temporary container for cremated remains.

State and local laws do not require a casket for direct cremation. If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The alternative containers we provide are cardboard containers without handles.
